### **Ordinance Number 2023-15**

# ORDINANCE LEVYING AND ASSESSING TAXES FOR CORPORATE PURPOSES OF THE VILLAGE OF SHERMAN, ILLINOIS FOR THE FISCAL YEAR COMMENCING MAY 1, 2023 AND ENDING APRIL 30, 2024

WHEREAS, there was passed by the President and Board of Trustees of the Village of Sherman Ordinance No. 2023-09, and published in pamphlet, the annual appropriations ordinance of the Village of Sherman, Illinois, for the fiscal year commencing May 1, 2022 and ending April 30, 2024.

WHEREAS, the total appropriation made in and by said annual appropriations ordinance to defray all necessary expenses and liabilities of the Village of Sherman, Illinois, for the fiscal year commencing May 1, 2023 and ending April 30, 2024 amounts to the sum of \$7,572,314 and

WHEREAS, the total amount of appropriations for all corporate purposes of said Village legally made and which are to be collected from the tax levy of and for the said fiscal year amounts to the sum of \$90,115.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustee of the Village of Sherman, Illinois as follows:

<u>Section 1</u>. There is hereby levied and assessed upon all property subject to taxation within said Village of Sherman, as the same is assessed and equalized for state and county purposes, for the fiscal year commencing May 1, 2023 and ending April 30, 2024, the following amounts for the following purposes:

General Fund:

\$90,115

<u>Section 2.</u> The funds levied in Section 1 above are hereby designated for use to pay the following specific items contained in the appropriation ordinance, Ordinance 2023-09.

General Fund:

\$90,115

<u>Section 3.</u> Warrants against and in anticipation of the above levied taxes for the payment of the ordinance expenses of said Village of Sherman for the fiscal year commencing May 1, 2023 and ending April 30, 2024 are hereby authorized to be drawn by the President and endorsed by the Treasurer of said Village of Sherman to the amount of seventy-five (75%) of amount of said taxes.

Section 4. The Village Clerk shall file with the County Clerk the County of Sangamon, State of Illinois, a certified copy of this ordinance, which shall be in lieu of any former levy ordinances for the said fiscal year, and said County Clerk shall extend the rate per centum which, upon the total value of all property subject to taxation within said Village of Sherman as the same is assessed and equalized for state and county purposes for the year 2023 will produce the net amount herein levied and ordered certified, and shall extend such tax upon the books of the collector for the state and county taxes within said Village of Sherman as provided bylaw.

<u>Section 5.</u> This ordinance shall take effect and be in force from and after its passage by the Board of Trustees of said Village and signing by the President of said Village.

<u>Section 6</u>. If any part of this ordinance shall be deemed to be invalid, the remaining parts shall remain in full force and effect.

<u>Section 7</u>. This ordinance shall be published by the Village Clerk in pamphlet form.
