ORDINANCE NO. 2024-07 AN ORDINANCE AMENDING ORDINANCE 1-7-1

NOW, THEREFORE, be it ordained, by the **President and Board of Trustees of the Village** of Sherman as follows:

SECTION 1 Ordinance 1-7-1 within the Village Code of Ordinances is hereby supplemented to include the following:

(D) Deputy Village Administrator. There is hereby created the position of Deputy Village Administrator. The Deputy shall be appointed by the Village President, with the consent of the majority of the board of trustees. The Deputy shall serve at the President's will, and shall report directly to the President and Village Administrator. The Village Administrator will be responsible for directing the daily activities, and assist in all ways with the Village Administrator's tasks as assigned by the President, including the implementation of short and long term goals; public relations; coordination with other taxing bodies of the Village; and oversight of the budget. The Deputy shall provide assistance, advice, and guidance to the Administrator to facilitate the Board's ability to plan for the future, develop sound policies and procedures, and respond to the citizenry. Compensation for the Deputy Village Administrator shall be set by the Village Board.

SECTION 2 This Ordinance is effective immediately.

SECTION 3 The Clerk is directed by the corporate authorities to publish this Ordinance in pamphlet form. This Ordinance shall be in full force and effect after its passage and publication in accordance with 65 ILCS 5/1-2-4.
